U.S. Presidential Scholars Program for CTE Students

The U.S. Presidential Scholars Program was established in 1964, by executive order of the President, to recognize and honor some of our nation's most distinguished graduating high school seniors. In 1979, the program was extended to recognize students who demonstrate exceptional talent in the visual, creative and performing arts.

In 2015, the program was again extended to recognize students who demonstrate ability and accomplishment in career and technical education fields. Each year, up to 161 students are named as Presidential Scholars, one of the nation's highest honors for high school students.

All high school seniors that are CTE Concentrators (3 Credits or more of CTE) and graduating between January and June of 2020, who are U.S. citizens or legal permanent residents and who attend public, parochial, or independent schools, as well as those who are home-schooled, are eligible.

The candidates will go through the application process, and as in the past, the 2020 U.S. Presidential Scholars will be selected by the Commission on Presidential Scholars and receive the Presidential Scholars Medallion at a ceremony in their honor in Washington, DC.

Nominations of Montana CTE students for the 2020 CTE U.S. Presidential Scholars Program are due October 15, 2019.

TEAMS (Terms of Employment, Accreditation, and Master Schedule) is Now Open—Ensure Your CTE Data is Correct

TEAMS is **now open** and closes on November 1, 2019. The OPI has updated security features for TEAMS and user accounts may be locked due to inactivity. If you experience login issues while trying to access TEAMS, please contact OPITEAMS@mt.gov. If you do not have access or need to grant access for an employee, please have the Authorized Representative (AR) complete the TEAMS Security Access Form.

Data from TEAMS pertaining to Career and Technical Education courses, student enrollments, and teacher certification is used for Carl Perkins accountability reporting and factors that determine the State CTE (State VoEd) funding allocations. Additionally, the data is also used to verify and approve Montana Career Pathways.

Therefore, it is imperative CTE teachers work with school/district officials to ensure the information submitted is complete and accurate.

Any high school district planning to apply for Carl Perkins and/or State CTE (State VoEd) funding for next year (2020-2021) should confirm the data in TEAMS for all CTE programs at their high school is correct.

The data for your program and courses within TEAMS should accurately reflect the following

- --Name of teacher(s) for courses
- --All current courses for the 2019-2020 school year are listed with the correct course title listed as the District Course Title
- --All courses listed are aligned to the correct Course Code & Title
- --Number of students enrolled and breakdown of males and females
- --Term Type for courses (Semester, Full Year, Quarter, etc.)
- -- Class Minutes (the minutes of instruction for each individual course per the term type)
- --If an extended contract is identified along with the number of days of the contract

To assist with providing the correct TEAMS data for your program and courses, a Montana OPI K-12 Course Codes and Descriptions Reference Manual for Business & Marketing Education and a worksheet to assist teachers and administrators with mapping district courses to the OPI K-12 Course Codes before the data is entered into TEAMS can also be download at http://bit.ly/MTBusEd19-20.

<u>Updated MT Business Education Planning Calendar, Framework, CTSO Crosswalks, & Course Codes Available for Download</u>

The <u>Framework for Business Education in Montana</u> has been updated for the 2019-2020 school year. Within the Framework, updates have been made to the competitive event crosswalks for Business Professionals of America and DECA. The updated crosswalks reflect updates and changes to the competitive event programs at the national level effective for the 2019-2020 school year.

The Framework for Business Education in Montana provides teachers with common guidance for curriculum development and course content development. Review and update work for the Framework for Business Education in Montana was by a committee Montana business education professionals representing all classifications of Montana High School as well as business education teacher program coordinators from the University of Montana and University of Montana Western and the State Directors for Business Professionals of America, Montana Association and Montana DECA.

The course information within the Framework is organized by Career Clusters with the Common Career Technical Core as the standards for each cluster. Additionally, course content is aligned to the *National Standards for Business Education* and is crosswalked to the *National Standards for Business Education* and to the competitive event programs for Business Professionals of America and DECA.

Also updated for the 2019-2020 school year is the OPI TEAMS Current Listing of All Montana K-12 Course Codes and Descriptions Reference Manual for Business & Marketing Education. The Montana K-12 Course Codes and Descriptions are used for the reporting of course taught in all schools and at all grade levels via the OPI TEAMS school staffing system. Updates to this year's manual include the removal of duplicated courses to help streamline course identification and the removal of "other" courses and codes. Additionally, the manual includes a complete listing of Montana teacher licensure course codes.

Within TEAMS, all courses taught are identified and aligned to a national SCED Code with the local school course title listed as well as term type, enrollment numbers, and length of instruction. For Montana's Career & Technical Education programs, the TEAMS data is also used to generate the Montana CTE Student Participation Reports which are used to determine State CTE/VoEd funding allocations.

Montana Students Eligible for \$10,000 Scholarship and Trip to Washington, D.C.

The United States Senate Youth Program (USSYP) and Montana Office of Public Instruction are pleased to announce that Montana high school juniors and seniors are eligible for a \$10,000 college scholarship and all-expense-paid trip to Washington, D.C to tour our nation's Capital and visit with leaders from all branches of the federal government. Two student delegates from each state will be chosen to participate in this prestigious program from March 7-14, 2020 for the program's 58th annual Washington Week.

The USSYP was created by Senate Resolution 324 in 1962 as stated in supporting Senate testimony from that year, "to increase young Americans' understanding of the interrelationship of the three branches of government, the caliber and responsibilities of federally elected and appointed officials, and the vital importance of democratic decision making not only for America but for people around the world."

"Civics education is critical to preparing the next generation of Montana leaders," said State Superintendent Elsie Arntzen. "I look forward to nominating robust student leaders to represent our state in the 2020 USSYP Program who will make Montana proud on the national stage."

Each year, this extremely competitive merit-based program brings two high school juniors and seniors from every state, the District of Columbia, and the Department of Defense Education Activity, to Washington, D.C. for an intensive week-long study of the federal government and its leaders. The state departments of education throughout the country select the students through a rigorous nomination and selection process. Each student will also receive a \$10,000 undergraduate college scholarship, with encouragement to continue coursework in history, government, and public affairs. The Hearst Foundations have fully funded and administered the program since inception; no government funds are utilized.

The student delegates will visit Capitol Hill, the White House, the Pentagon, the State Department, the Supreme Court, and many other historic sites in Washington. The program agenda routinely includes meetings with Senators, the President, Cabinet Secretaries, a Justice of the Supreme Court, senior members of the national media, and other key policymakers. Each speaking event incorporates detailed question and answer sessions. This high-level exposure is precisely what fuels and sustains the delegates' commitment to making a difference in their country, communities, and schools.

Fun Facts and Trivia

Dragon fruit is unlike any other fruit; it is not produced by a tree, but rather from a fruit-bearing species of cacti which is native to Central and South America.

Today, dragon fruit are commercially cultivated in Southeast Asia.

Dragon fruit are cultivated in Southeast Asia, the United States, Israel, Australia, Cyprus and the Canary Islands.

Dragon fruit is also known as strawberry pear or pitaya.

The names "pitahaya" and "pitaya" comes from Mexico, and "pitaya roja" in Central America and northern South America, possibly relating to pitahaya for names of tall cacti species with flowering fruit.

According to Aztec literature, Pitahaya fruits date back to the 13th century.

French missionaries were the first to export the fruit from central America to south east Asia, where it was called dragon fruit. This name is supposed to derive from a legend, according to which, the fruit was the last breath exhaled by a dragon defeated in battle.

The red-fleshed variety of dragon fruit contains lycopene, the same antioxidant found in tomatoes, which helps in lowering the risk of cancer, hypertension and heart disease.

Dragon fruit is similar to the more average-looking fruits in that it contains several nutrients good for the body including B-complex vitamins and Vitamin C; iron, calcium, phosphorus and antioxidants.

The dragon fruit's seeds also contribute to its nutritional benefit as they contain protein as well as omega-3 and omega-6 fatty acids that can help prevent cardiovascular diseases.

Taiwanese doctors are said to recommend dragon fruits to patients with diabetes, to help normalize blood sugar levels.

A concoction made of dragon fruit, honey, and cucumber juice can moisturize and soothe sunburned skin.

Dragon fruit is usually eaten fresh, but Nicaraguans are fond of drinking a beverage made from crushed dragon fruit, water and lime juice.

The cactus flower that produces dragon fruit survives only a single night—it blooms in the evening, ready for pollination by baths and moths, and wilts the very next day.

The flower buds of dragon fruit are edible.

You can slice the dragon fruit in half like any other melon and then slice the flesh like a watermelon; or, use a melon baller to scoop the fruit out.
