Diane Marsh, Columbia Falls Business Educator, Named 2020 Outstanding Technology Educator of the Year

Since changing her career from marketing to education, Columbia Falls High School business and technology teacher Diane Marsh has used previous real-world marketing experience and ever-expanding accreditation to provide students with the most relevant education possible.

The combination helped earn her the 2020 Outstanding Technology Teacher of the Year award, presented by the Northwest Council for Computer Education, an organization based out of Coeur D'Alene, Idaho.

"Diane inspires other educators in the northwest with new approaches and ideas that make a difference for students, staff and the community," Heidi Rogers, NCCE CEO said. "She is never standing still and she is the first to learn something and share it with others. She overwhelmingly received this award due in part to her commitment and dedication to students, but also for her innovative teaching approach as an online instructor as well as being a traditional classroom teacher."

"She's definitely our leader in making sure everybody's needs are met for whatever technology they need," said Marsh's business and technology colleague Becky Bates. "She doesn't technically have a title or anything, but she really assumes that role of professional development for our staff."

A role that has been in high demand since the start of the coronavirus pandemic in March, when Marsh has been helping teachers transition from face-to-face to, increasingly, online classrooms.

Bates nominated Marsh for the award in January, and Marsh received it at a ceremony in Seattle a week before schools began shutting down for the pandemic.

Fun Facts and Trivia

Fingerfish are found from the Atlantic coast of western Africa to the Indo-Pacific region.

Fingerfish usually inhabit inshore or estuarine waters.

Fingerfish are extremely compressed and deep-bodied and are often greater in height than in length.

Fingerfish get their names from their long dorsal and anal fins, making them look like fingers.

Fingerfish are a popular aquarium fish.

Fingerfish can grow to become eight-nine inches in length and have two black bands extending vertically down their head.

If planning to have fingerfish in an aquarium, be sure to get a big tank as most sold in pet stores are juveniles.

Fingerfish are shoaling fish, so you need to have a large enough tank to house at least 4-6 of them.

Fingerfish are not solitary fish; therefore, they need members of their own species present in order to thrive.

Juvenile fingerfish can survive in the freshwater; however, as they get older, they prefer saltier waters.

Fingerfish are omnivores, eating both meaty and plant-based foods.

Be sure not to confuse fingerfish with fish fingers.

Fish fingers, or fish sticks, are a processed food made using a whitefish, such as cod, hake, haddock or pollock, which has been battered or breaded.

In 1900, a British popular magazine first cited the term fish finger in a recipe.

In 1953, fish finger became a commercial dish after the first ready-to-cook fish finger was sold as a frozen food.

The manufacturer was the American company Gorton Pew Fisheries; known today as Gorton's.

Gorton Pew Fisheries called their fish fingers "Gorton's Fish Sticks."

Gorton's was founded in 1849 in Gloucester, Massachusetts.

The iconic Gorton Fisherman first appeared in 1975.
